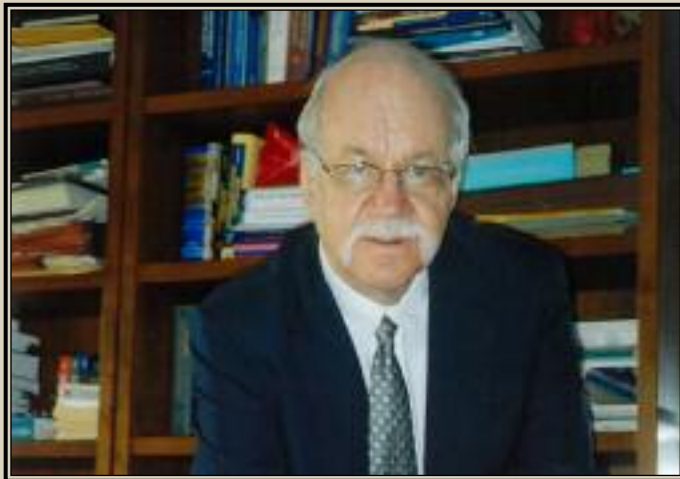

### WHY DO WE BELIEVE SHARP LEVEL II CFA PREP COURSE IN NEW YORK IS THE BEST?

Rigor Of CFA Program

In general, each level of the CFA Program requires a minimum of 300 hours of preparation, although time will vary from candidate to candidate based on familiarity with the material.

Learning outcome statements are meant only as a guide to the most important knowledge, skills and abilities to be gained in the readings. CFA Program reading assignments compose the core of study. Prep Provider courses and materials are developed to complement the core curriculum and to facilitate the learning process, not to be used as a substitute for study of the prescribed curriculum.
